# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.isicpi.com, and MacCurdy and Associates and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MacCurdy and Associates include www.isicpi.com and ISI. The ISI website provides information regarding the products and services offered to the financial institution industry. By using the ISI website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. # **Sharing Information with Third Parties**

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. ISI may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ISI, and they are required to maintain the confidentiality of your information.

#### **Use of Cookies**
